10. CASUAL VACANCY

There was a discussion on the Casual Vacancy and it was decided to Co-Opt Mr Kevin Salter as the new Parish Councillor.

11. GRANT AID

- Toddle and Tumble Group requested £350.00 towards the purchase of a new Sand Pit. Councillor Mrs A. Green proposed that the amount of £350.00 (three hundred and fifty pounds only) be granted to the Toddle and Tumble Group. This was seconded by Councillor Mrs P. Ansell and it was

RESOLVED That: The Toddle and Tumble Group be granted £350.00 (three hundred and fifty pounds only)

12. CHRITMAS LIGHTS

The Council decided to use Turnocks Ltd for the installation, dismantling and testing of the Christmas Lights.

RESOLVED That: Turnocks Ltd be used for the installation, dismantling and testing of the Christmas Lights.

13. VILLAGE HALL DEFIBRILLATOR

The Village Hall is in need of £515.00 (five hundred and fifteen pounds only) to cover the shortfall for the Defibrillator. The Council had agreed to cover this in previously.

RESOLVED That: £515.00 (five hundred and fifteen pounds only) be gifted to the Village Hall Committee for the shortfall on the defibrillator.

14. VILLAGE GREEN SITES FOR PLANTING

District Councillor M. Buttery stated that he would look in to the matter of the crocuses for Councillor R. Poynton and also what is happening regarding the planting.

15. GRITTING AND HIGHWAYS

Councillor I. Bamford stated that the Gritting Bin at Holly Hill Road is empty and the one on Park Gate Road is half full. The one on Chapel Lane is overgrown and hidden and Councillor I. Bamford would clear this.

The Clerk was to write to County Councillors B. Jones and P. Hewitt regarding the gritting routes for village.

There is concern that some of the lamp posts up Chestall Road and Holly Hill Road have become imbedded in the tree and this was affecting the amount of light from them. The Parish Clerk would look in to this matter.
