

# Cannock Wood Parish Council

Minutes of the Parish Council Meeting  
Held at the Village Hall Buds Road,  
Cannock Wood on Thursday 18<sup>th</sup> June 2009, at 7.30 pm.

## **Public Participation**

Mrs Y. Nicholls of 6 Hayfield Hill expressed concerns about the bus stops in the Village especially the one located outside her property. The 6.40 a.m. bus parks at the bus stop and leaves the engine running for many minutes which wakes them up as their bedroom is on the front of their property. Also when buses are parked at the stop during the day, it makes getting out of their driveway very dangerous as the bus stop is close to the junction of Hayfield Hill/Cumberledge Hill. Mrs Nicholls had contacted Arriva about the problems but nothing had happened. Cllr's agreed this was not satisfactory and informed Mrs Nicholls that concerns had been raised at the last meeting and Cllr Healey had undertaken a survey of all stops. This was discussed with Mrs Nicholls and Cllr's agreed that the way forward should be to ask a representative from Arriva to attend a meeting of the Council in the future to discuss the many issues that had been identified. Cllr Healey agreed to pass on the survey to the Clerk and also contact details of someone at Arriva.

Mr & Mrs D. Brown of 17 Pineside Avenue informed Cllr's that new street lighting was being installed in Pineside Avenue and a lamppost had been sited right outside their property. This was a great concern to them as their young child's bedroom is on the front of the house and they feel the light will keep the child awake. They have been told that the new lights are four time stronger than the old ones. A worker involved in the installation of the new lights told a neighbour they needed to get thicker curtains. Cllr's discussed the problem and agreed that there ought to be a satisfactory solution to the problem. It was agreed that the Clerk would write to the Principal Lighting engineer and ask that the situation be looked in to and the lamppost moved to a new position. Mr & Mrs Brown agreed to keep in contact with the Clerk updating him on the situation.

Mrs R. Taylor of 28 Cumberledge Hill told Cllr's she was very concerned about the speed of cars using Village roads, especially Cumberledge Hill where she lived. She felt that sooner or later there would be a serious accident due to the problem. Cllr's told Mrs Taylor that they had been asking for various measures to be introduced to deter speeding on Village roads but nothing had happened. It was felt that the Police should look at undertaking more speed checks in the Village and also ask the County Council to look at the possibility of getting deterrents installed on the roads, like chicanes. The Clerk agreed to contact the Village bobby about the problem and also write to highways asking what could be done.

All residents then left the meeting.

Apologies had been received from Cllr's Powis and Mawle.

### **2. Approval of Minutes for the Meeting held on Thursday 21<sup>st</sup> May 2009.**

The minutes of the meeting were read and accepted as a true record.

Cllr Ansell informed Cllr's that she had spoken with Cllr Mawle who had informed her that the Oak Tree that had been reported by Mr Potts at the APM would hopefully be cut back within the next few days.

**11. Road Safety within the Village.**

Cllr Bamford stated that some issues had been mentioned to him and he agreed to forward details via an email to the Clerk.

Cllr Healey went through the report on the bus stops in the Village that he had undertaken. There were issues with several stops and Cllr Healey reported that a friend had reported the stop in Hayfield Hill, opposite the Redmoor Public House because he felt it was very dangerous. Arriva had not given any satisfactory replies. Cllr's felt that the whole issue of bus stops should be discussed with Arriva and the best way forward was to try to get a representative to attend a meeting in the future. Cllr Healey agreed to pass on contact details for Arriva to the Clerk so that he could contact them and invite them to attend a meeting in the future.

The Clerk informed Cllr's that the Web Pages were up and running and had spoken with Cllr Powis who was keen that people look at the site and see if any updates needed to be made. Cllr's to give feedback at the next meeting.
