We welcome them both to the Parish Council and thank those who have served the village so well.

This is an election year. One of our long standing Councillors, Richard Poynton , has decided not to stand for re-election.

I would like to thank Richard for all his work on the Parish Council, he will be missed.

All six of your other Councillors have put themselves forward to serve again, and since noone else has come forward, are elected unopposed.

Your Parish Council for the next term therefore comprises Pat Ansell, Avril Green, Fiona McMulkin, Liz Whiteley, Steve Wroe and myself, Sue Janes.

This still leaves us one person under full strength, and if anyone would like to offer their services to the community, please contact the Clerk.

The Working Group made excellent progress with the Neighbourhood Plan under the leadership of Liz Whiteley. It was submitted to Cannock Chase District Council in October, having gone through all the necessary consultations.

Unfortunately CCDC have told us that they cannot consider it whilst they are working on the Local Plan. We feel the delay is unacceptable and we are trying, in every way we can, to hurry things along.

There have been several very successful events in the village this year. The Jubilee picnic, a Scarecrow competition, the lighting of the Christmas Tree and an Easter Eggstravaganza

were all supported by the Parish Council. Thanks to all those who made these thoroughly enjoyable events happen.

The Parish Council has supported several organisations with grants this year. Our priority is always the villages main assets, the Village Hall and the Playing Field, but we have also been able to assist Burntwood First Responders, Beaudesert Activity Centre Trust ,Katherine House Hospice, Cannock Wood Methodist Church, Christ Church Gentleshaw, the Rag Bowling Club and Cannock Wood Welfare Committee.

We have also received grant money to help with improvements to our environment.

Speed warning signs have been installed by the school to try to make the area safer.

We are still working with Longdon Parish Council and Staffordshire CC to make the problems of parking at school drop off and collecting times as safe as possible

I am sure you have all noticed the planting at the triangle in the centre of the village.

Bullbs have also been planted in various green areas of the village.

This has been carried out by the Environmental Group with the help and advice of Jim Haston, our thanks for his help. I am sure other environmental improvements to our village will follow and I look forward to seeing them blossom.

Once again I conclude with my thanks to all Councillors for their hard work and commitment and most especially to our Clerk, Chris Gracey, who gives us her support in everything we do.
