14. Minute number 493/2023 – Christmas Tree 2022 – Members discussed the event and reported that it was well attended & received, although the weather was poor and residents had to queue to get into the village hall, because of the weather some of the residents went home.

Cllr. Steve Wroe (Vice-chairman) reported on the problems in getting the tree erected, the installation of the lights & the electricity supply. In future we need to consider this project well ahead of Christmas, pre-book the cherry picker, an electrician to test the supply and get more volunteers to assist, this was agreed. It was also agreed that the fence panels would be cut down so that the tree isn't obstructed and the lights & fencing panels would be stored in either the pavilion or the container at the village hall. Volunteers are needed to assist with moving the fence panels to their new location and assist in cutting them down.
