Minute number 85/2023/A Members of the public – Cllr. Trevor Johnson from Longdon Parish Council reported that he had met with Michael Fabricant MP to discuss reducing speed on country roads from 60mph to 40mph, his advice was to apply for three roads initially and if this is successful to apply for more. The initial roads would be Church Hill, Borough Lane both in Longdon along with Malthouse Lane in Gentleshaw for the later location the support of CWPC may be required and he hoped that both parishes could work together to enable a similar goal.

Holly Hill Road near to 55, complaint of flooding. Works have been raised to jet the 3 gullies, 2308119/2308118/2308117. the scheduler to programme these in.

Holly Hill Road in the dip between Castle Ring car park and Park Lodge – we have asked our technical review officer/drainage engineer to visit site and have a look to see what can be done to try and help.

21st September 2023 Cannock Wood PC Minutes Chair initials..... Cumberledge Hill opposite Chapel Lane – we have asked the tree officer to take a look at this tree and overgrowth -4341014

Cumberledge Hill footway from Slang Lane to nature reserve – we have added this to the list if possible environmental monies were to become available to clear the back of the footway.

Hedges around signs – we will look into these to see what we can do about them to improve visibility of the sign. The council will write to the farmer on Buds Road regards the school sign.

The Japanese knotweed on Holly Hill Road is on the list and is due to have its second spray this year week commencing 4th September.

Over and above, Just to let you know that the additional investment team are due to be in Holly Hill Lane, Monday 18th September to carry out works to the carriageway potholes. The team will be carrying out these works under a road closure and will possibly be on site for 2 days, I added this to a list a couple of months ago.

I do want to discuss speeding in the village, I recently had a meeting with the Police Inspector and talked about a local Police enforcement team, I want to explore this further in Cannock Wood.
