There is also a proposal to drop the kerb at the centre access to facilitate everyone and their needs. The location is considered by the committee to be the safest place, the equipment is module and can be placed is any shape. The committee are holding a consultation with residents and hirers on their proposals, dates to be confirmed. The new equipment will hopefully give users a better play experience for 6-14 year olds.

The Chairman of the Committee spoke about the recent damage to field due to the long spell of wet weather and the use by hirers. The Field committee have proposals to avoid such damage and to repair the existing damage as soon as the weather is finer. The field will be rolled and damaged areas will be re-seeded.

1.Gap closing in field, as agreed he visited the field off Chestall Road, Cannock Wood with a Community Highways Officer last Friday and did happen to run into the Chair of the Parish as we were assessing the hedgerow and entrances to the field.

It will ultimately be the landowners decision as the hedge belongs to that land.

Permission is not needed from Staffordshire County Council Highways as we do not own or maintain the hedgerow in question. My recommendations would be to ensure that the other gaps are safe to access and use from the highway before closing off the access in question, e.g. visibility, any restricted access such as high kerbs. Currently the access in question has a dropped kerb for ease of access, the next one down does not, any drop kerbs fitted would be at the cost of the field owner.

- 2. We continue to have issues with flooding in Holly Hill Road, this is an on-going issue that despite lots of effort we have not resolved it long term, we have a renewed plan and have visited the resident affected.
- 3. Red water is again running down Cumberledge Hill, I have reported it.
- 4. I'm told that the hedge at 84, Hayfield has been cut back.
- 5. Our transport team have spoken to the bus company about the 62 routing, I think this needs a discussion can we please add to next meeting's agenda.
