# 7. Minutes number 513/2025 To receive reports from Councillors who have attended outside meetings:

Cllr. Steve Wroe (Vice-chairman) had attended the National Landscape conference on 12th June 2025

Summary of key discussions affecting Cannock Wood

### **Introduction (Cllr Tony Pearce (Stafford)**

The new government has doubled the housing targets and at the same time increased the size of the housing supply from 5 to 6 years. The doubling of the targets has therefore effectively reduced Stafford's housing supply from 6 to 3 years. The net result is that there will be a need to find new land for housing and this will put pressure on settlement boundaries and green belt. Tony thinks Cannock's situation is a little better than Stafford but not greatly. The Local Plan's will need to be amended.

NL funds have reduced and as a consequence they no longer have a planning officer. This means they may only be able to comment on larger or proposals with more impact and will need to pay for a consultant.

Both the above will put pressure on land use and, at the same time, adversely affect our ability to oppose developments.

NL handed out copies of the new 5 year plan. I have a copy if anyone wants to borrow it although I guess it will be on the website. The plan includes for a possible nature reserve within Cannock Chase.

### **Groups Projects**

A number of speakers were given 3 minute slots to describe a project they have been involved in:

John Hill described new history tours at Beau which will be held monthly.

**Shugborough Trust -** described work at Shugborough by NT to create a 2 acre Forest Garden, due to open spring 26. The concept is to use plants which support each other and to encourage everyone to have a go to extend the benefits of domestic gardens. Some tours are available now to see the works. See NT websites.

**Haley Dorrington (SWT)** – described work at Etchinghill and Gentleshaw Common and a plan to create a heathland corridor between the two sites. An additional sundew has been identified on Gentleshaw Common where there are now 3 species.

**Green Funding Team – (part of National Landscapes Association)** described reduced funding from DEFRA and the need to make up from corporate and private finance. There is a drive to persuade corporates to set aside more funds and the government will possibly make it mandatory to include their contributions to the environment in their annual reports which should drive revenue.

Also in the plan is a proposal to create a wildlife corridor joining Rawnsley Nature Reserve to Castle Ring and Beau. We should be able to follow this on the website but it is early days. Andrea would be interested in this.

**Claire Gegan –** described Guidance Documents for Land Managers and said work was being done at the sawmill on Beaudesert Farm.

Other afternoon longer presentations described how the National Forest was set up, grown and is being managed and an interesting presentation from Chris Sands – check The Good Company and Totally Locally for details of his approach and projects. Interesting.

The longer presentations should be uploaded onto the NL website.

The day concluded with a walk around Beaudesert Golf Club to see how they are managing dense self-sown pine stands to encourage heather growth.

I also met Suzanne Wykes from CCDC who plans to carry out a flora survey at Nunswell Park in June/July. She will then issue a report combining this with the results of last years bird survey. The aim is to draw up an action plan (although there is limited money available). The PC will be invited to comment on the report and meet at site later in the summer.

Cllr. Elizabeth Whiteley attended the remote seminar on Reorganisation of Local Councils, she proposed that the clerk asks for a FOI request to CCDC for the figures of the annual budget for Nunswell.
